Heard the learned counsel for the petitioner and the learned Government Pleader for Cooperation appearing on behalf of the respondents. With their consent, the present Writ Petition is being disposed of at the admission stage itself.

Seeking to declare the action of the respondents for not taking any action on the application dated 27.11.2021 for change of body of the society of "Compassion's fire Ministries International Hyderabad" despite the society passed a resolution to change its body, as illegal and arbitrary, the petitioner has filed the present Writ Petition.

Having regard to the fact that the petitioner has already given application dated 27.11.2021 to the respondent No.3 - Registrar of Societies, Hyderabad, for change of the body of the society, without going into the merits or demerits of the case, this Writ Petition is disposed of with the direction to the respondent No.3 to take necessary action pursuant to the

petitioner's application dated 27.11.2021, as expeditiously as possible, preferably, within a period of two (2) weeks from the date of receipt of a copy of this Order.

Miscellaneous applications, if any pending, shall stand closed. There shall be no order as to costs.
