THE HON'BLE SMT. JUSTICE LALITHA KANNEGANTI WRIT PETITION No. 12059 OF 2022

ORDER:

This Writ Petition is filed questioning the action of Respondents 2 to 5 in trying to dispossess the petitioner from Part of Plot Nos. 15 and 16, Syamala Nagar, Shivarampally, Rajendernagar, Ranga Reddy District, without following due process of law, as arbitrary and illegal.

- 2. Sri Ahmed Ehtesham Kawkab, learned counsel for the petitioner submits that in the year 2004, the petitioner constructed a small house by obtaining permission for the authorities and also by following necessary norms and procedure. He submits that the official respondents without issuing any notice and without following due process are trying to interfere with the petitioner's possession and trying to demolish the house at the behest of the unofficial respondent, hence, the petitioner approached this Court. It is stated that this Court has granted interim order on 07.03.2022 and the same is subsisting.
- On the other hand, learned Standing Counsel for the respondent Corporation Srt Pasham Krishna Reddy submits that the Corporation has already issued notice to the petitioner

under Sections 452(1) and 452(2) of the Greater Hyderabad Municipal Corporation Act and they will take appropriate action in accordance with law.

- Learned counsel for the petitioner submits that no such notice was issued to the petitioner.
- 5. In the facts and circumstances of the case, the Writ Petition is disposed of directing the respondent Corporation to issue fresh notice to the petitioner and take appropriate action in accordance with law. Till then, the respondent authorities shall not take any coercive steps against the petitioner. There shall be no order as to costs.
- The Miscellaneous Applications, if any shall stand automatically closed.
