**ORDER:-**

1. This Writ Petition is filed seeking a 'Writ of Mandamus' declaring the action of Respondents 2 to 4 in not taking any action against the illegal construction carried out by Respondents Nos.5 & 6 over Plot bearing No.198 in Sy.No.21, 22, 29, 30, 31, 34 to 40, admeasuring 950 Sq.yards, situated at Sri Ram Nagar Colony, Gajularamapuram Village, Quthbullapur Mandal, Medchal (Malkajgiri) District as illegal.

2. Learned counsel for the petitioner submitted that final orders were passed by the Municipality and as such, the Writ Petition becomes infructuous.
