**ORDER:-**

1. The present Civil Revision Petition is filed against the docket proceedings dated 19.01.2022, in I.A.No.1 of 2021 in O.S.No.4 of 2021, on the file of the Court of V Additional District Judge, Kothagudem.
2. Heard learned counsel for the petitioners.
3. Learned counsel for the petitioners submitted that I.A.No.1 of 2021 is filed by the respondents 1 & 2/plaintiffs before the Court of V Additional District Judge, Kothagudem, seeking interim injunction. The trial Court granted status quo on 13.07.2021 and it is being extended from time to time. The defendants have filed their counter in the said petition and were insisting for early hearing. But the trial Court, without hearing them, extending the said status quo order from time to time. Hence, the present petition is filed requesting this Court to give a direction to the trial Court for passing orders on the said I.A.No.1 of 2021.
4. Considering the docket orders in this matter, this Court deems fit to direct the V Additional District Judge, Kothagudem,

to pass orders on merits in I.A.No.1 of 2021, after hearing both the parties, within a period of 30 days from the date of receipt of copy of this order.

5. With this observation, the Civil Revision Petition is disposed of. There shall be no order as to costs.

6. Miscellaneous petitions, if any pending, shall stand closed.
