Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of writ fo Mandamus: i) declaring the inaction of the respondents in not selecting the petitioner as Assistant Professor, Computer Science & Engineering pursuant to the Notification issued by the 1st Respondent in Advertisement No. 1/2006 dt. 8-9-2006 while selecting the 2nd respondent, who is lesser qualified than the petitioner, though the petitioner more qualified and eligible to be appointed as against the post of Assistant Professor, Computer science & Engineering meant for O.C. (W) and O.C. (General) as illegal, arbitrary and unconstitutional apart from being violative of principles of natural justice, and as against the various judgments rendered by the Hon'ble Supreme Court as well as this Hon'ble Court consequently ii) direct the respondents to appoint the petitioner as Assistant Professor, Computer Science & Engineering either as against O.C. (W) or O.C. (General) Category, pursuant to the Notification issued by the 1st

Respondent in Advertisement No. 1/2006 dt. 8-9-2006 by setting aside the selection and appointment of the 2nd respondent in case the petitioner is to be appointed as against O.C. (W) category; and iii) pass such other order or orders as the Hon'ble Court deem fit proper and appropriate in the circumstances of the case.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 1st respondent to appoint the petitioner as Assistant Professor, Computer Science & Engineering, as against the existing Vacancy, pending disposal of the above writ petition.,
