This Criminal Petition is filed by the petitioners-Accused Nos.1 and 2 under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') seeking to quash the proceedings against them in FIR No.333 of 2020 on the file of Station House Officer, Palavantha Town Police Station, Kothagudem Kothagudem District registered for the offences under Sections 294-B, 323 and 506 read with Section 34 of Indian Penal Code (IPC).

2. Heard. Perused the record.
3. Learned counsel for the petitioners submits that earlier a complaint was filed on the very same allegations, which was investigated and filed charge sheet before the concerned Court, which is pending trial before the trial Court.
