ORDER

This writ petition is filed questioning the action of the official respondents in not taking action against the illegal constructions being made by respondent Nos.9 to 13 in the part of open land in Sy.No.332/1, situated at Attapur Village, Phadi Mir Mohammod Aulla Rajendranagar Mandal, Ranga Reddy District, in spite of the petitioner's representation dated 19-04-2022, as illegal and arbitrary.

- 2 Heard learned counsel for the petitioner Mr. R.R.Kalyan, learned Government Pleader for Municipal Administration and Urban Development for respondent No.1, learned Standing Counsel for respondent Nos.2 to 6 Mr. Pasham Krishna Reddy and learned Government Pleader for Revenue for respondent Nos.7 and 8.
- 3. Learned counsel for the petitioner submits that the unofficial respondents are making unauthorized constructions in a small part of the aforesaid land and in spite of the representation made by petitioner on 19-04-2022, the official respondents have failed to consider the same and hence, the petitioner has approached this Court.
- Learned Standing Counsel for respondent Nos.2 to 6 submits that the official respondents will consider the representation of

petitioner dated 19 04-2022 and they will take appropriate action in accordance with law.

- 5. Recording the submission of the learned Standing Counsel, the Writ Petition is disposed of, directing respondent Nos 2 to 6 to consider the representation of petitioner dated 19-04-2022 and take appropriate action in accordance with law within a period of 4 weeks from the date of receipt of a copy of this order. No order as to costs.
- Miscellaneous petitions, if any pending in this writ petition, shall stand closed.
