Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the respondents herein in not considering the representation dated 04/02/2022 made before the respondent Nos.2 to 4 for entering into the subject land i.e., agricultural land admeasuring an extent of Ac.1.00 in Sy No.250/26 situated at Anazipur Village Bhuvanagiri Mandal, Yadadri Bhuvanagiri District, erstwhile Nalgonda District in E-Passbook of Telangana State and not issuing the E-Passbook is illegal, arbitrary and in violation of principles of natural justice and also against the provision of ROR Act and against all the settled principles of law and consequently direct the respondnets to enter the subject property i.e., agricultural land admeasuring an extent of Ac.1.00 in Sy No.250/26 situated at Anazipur Village Bhuvanagiri

Mandal, Yadadri Bhuvanagiri District, erstwhile Nalgonda District in E-Passbook and issue the same.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the representation dated 04/02/2022 with regard to the subject property i.e., agricultural land admeasuring an extent of Ac.1.00 in Sy No.250/26 situated at Anazipur Village Bhuvanagiri Mandal, Yadadri Bhuvanagiri District, erstwhile Nalgonda District and issue the E-Passbook, pending disposal of the above Writ Petition.

ORDER:

Heard learned counsel for the petitioner and learned Government Pleader for Revenue appearing for the respondents.

With their consent, this Writ Petition is disposed of at the admission stage.

- 2. This Writ Petition is filed seeking Writ of Mandamus by declaring the action of the respondents herein in not considering the representation dated 04-02-2022 made before the respondent Nos 2 to 4 for entering into the subject land i.e., Agricultural land admeasuring of Ac.01-00 in Sy.No.250/26 situated at Anazipur Village, Bhuvanagiri Mandal, Yadadri Bhuvanagiri District, erstwhile Nalgonda District in E-Passbook of Telangana State and not issuing the E-Passbook is illegal and arbitrary.
- Learned counsel for petitioner contended that the petitioner herein succeed an extent of Ac.01-00 in Sy.No.250/26

situated at Anazipur Village, Bhuvanagiri Mandal, Yadadri Bhuvanagiri District, erstwhile Nalgonda District, from her husband and the said land was mutated in her name after demise of her husband and she was also issued pattadar passbook in her favour vide Patta No.979 as early as in the year 2015. However, after introduction of Dharani portal, the name of the petitioner is recorded in Dharani portal in respect of said extent of land and the petitioner is not being issued with new pattadar passbooks.

4. According to the petitioner, the said land is an assigned land in favour of her husband and it is now succeeded by the petitioner for want of issuance of new pattadar passbooks and the petitioner deprived of enjoying the said extent of land, including receiving benefit of Rythu Bandhu Scheme. In view of the same, the petitioner claims to have submitted Written Representation on 04-02-2022 and Online Application on 08-09-2021 vide Transaction ID No. TTDER022100685922, to the respondents No.2 to 4 herein.

- 5. According to the learned counsel for the petitioner, the said. Written Representation on 04-02-2022 and Online Application on 08-09-2021 vide Transaction ID No. TTDER022100685922 are still pending till date. Therefore, the learned counsel for the petitioner seeks the intervention of this Court to direct the respondents to consider the said representation and online application, in accordance with law and for passing appropriate Orders within a time frame fixed by this Court.
- 6. Taking into consideration of the facts and circumstances of the case, without going into the merits and demerits, this Writ Petition is disposed of directing the Respondent No.2 herein to consider the Written Representation on 04-02-2022 and Online Application on 08-09-2021 vide Transaction IID No. TTDER022100685922 submitted by the petitioner for issuance of new pattadar passbook in the name of the petitioner, and pass a appropriate orders within a period of Four (4) Weeks from the date of receipt of copy of this Order and communicate the same to the petitioner.


