ORDER:

This writ petition is filed questioning the action of the respondent Nos.1 and 2 in not taking appropriate action on the applications of the petitioner dated 26.04.2022, 06.05.2022 and 09.05.2022 for demolishing the illegal construction of the multi-storied building that is being constructed by the respondent Nos.3 and 4 in Plot No.16, admeasuring 60sq.yds situated at Sanghambhavanam, Mahaveernagar Colony, Gudimalkapur, Mehdipatnam, Hyderabad without having valid building permission, as illegal and arbitrary.

- 2. Mr. Abdul Wahid Bahsha, learned counsel for the petitioner submits that the petitioner has made representation with regard to the illegal constructions made by the unofficial respondents. He submits that in spite of that, no action has been initiated by the respondents.
- Mr. N. Ashok Kumar, learned standing counsel for respondent municipality submits that on 23:07:2022, they have issued a show cause notice to the unofficial respondent and they will take further action.
- 4. Recording the said submission of learned standing counsel, this writ petition is disposed of directing the respondents to take further action in accordance with law within a period of four (4) weeks from the date of receipt of

copy of the order. The respondents shall issue notice to the unofficial respondents before passing orders. No order as to costs.

Miscellancous petitions, if any pending in this writ petition shall stand closed.
