ORDER:

This Contempt Case is filed alleging willful disobedience to the order dated 15.04.2021 passed by this Court in W.P.No 9547 of 2021. By the said order, this Court has directed the competent authority to consider the representations made by the petitioner on 06.01.2021, 19.01.2021 and 20.02.2021, and if the allegations made therein are found to be true, take necessary action forthwith, strictly in accordance with law, duly putting the petitioner as well as respondent No.6 therein on notice and affording them an opportunity of hearing.


Respondent Nos.1 to 3 have filed a counter affidavit stating that the respondent Corporation has complied with the order of this Court dated 15.04.2021 and have seized the subject premises in accordance with law.

Having regard to the above averment made in the counter affidavit, nothing survives for adjudication in the present Contempt Case, and the same is, accordingly, closed. However, it is made clear that the respondent - Corporation shall not permit the unofficial respondent in W.P.No.9547 of 2021 to conduct any business in the subject premises, without there being any trade licence or clearance from the Pollution Control Board.

The Miscellaneous Applications pending, if any, shall also stand closed.
There shall be no order as to costs.
