This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri Nandigam Krishna Rao ,Advocate for the Petitioner and of the Public Prosecutor for the State of Telangana on behalf of the Respondent No. 1.

**The Court made the following: ORDER**

CRIMINAL PETITION No.7921 OF 2022

ORDER:

This Criminal Petition is filed under Sections 437 and 439 of Code of Criminal Procedure, 1973 seeking to enlarge the petitioner/accused No.1 on bail in connection with Crime No.78 of 2022 pending on the file of Tekulapalli Police Station, Bhadravati Kothagudem District, registered for the offences punishable under Sections 8(c) and 20(b) of Narcotic Drugs and Psychotropic Substances Act, 1985 (for short "N.D.P.S.Act, 1985").

2. The case against the petitioner is that he was found in possession of 78.5 Kgs. of Ganja, while transporting the same in Maruthi Omni Van bearing registration No.TS-04/EQ-5027. The said Ganja was seized by Tekulapalli Police on 29.05.2022. After following the procedure prescribed under N.D.P.S.Act, 1985, the samples of contraband was sent to Forensic Science Laboratory.
3. Learned counsel for the petitioner submits that the petitioner/accused No.1 is driver-cum-owner of the vehicle and he is unaware of the contraband, which he was transporting at the instance of accused No.2.


4. Since the case is under investigation and the contraband seized is above commercial quantity, this Court is not inclined to grant bail to the petitioner/accused No.1 at this juncture. However, the petitioner/accused No.1 is at liberty to move bail application under changed circumstances.

5. Accordingly, the Criminal Petition is disposed of.

6. Pending miscellaneous applications, if any, in this criminal petition, shall stand closed.
