**ORDER:**

This application is filed by the applicant to appoint a sole arbitrator to resolve the disputes between the applicant and the respondent in terms of clause 15 of the Agreement dated 27.10.2004 read with clause 2 of the Renewal Agreement dated 13.09.2019.

2. Both the learned counsel for the parties consented for appointment of arbitrator in terms of clause 15 of the Agreement dated 27.10.2004 read with clause 2 of the Renewal Agreement dated 13.09.2019.

3. Having regard to the fact that there is no dispute with regard to existence of the arbitration clause in the agreement entered into between the parties, the arbitration application is allowed.

4. In view of the same, arbitration application is allowed. Mr. K.
