Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Wirt of Mandamus or any other appropriate Writ or order or direction declaring the inaction of the respondents in providing power supply to the HT Service Connection vide HT Reference No.HT99923780, date of registration 07/08/2019 issued by the Southern Power Distribution Company of TS Limited, Vikarabad CSC, as arbitrary, contrary to Article 14, 19(i) (g) and 300A of the Constitution of India and the same is in violation of principles of natural justice, without authority of law and consequently direct the respondents to release the power to the HT Service Connection of the petitioner forthwith.
