This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of M/s. G. Uma Rani, Advocate for the Petitioner and the Additional Public Prosecutor on behalf of the Respondent No.1 and None Appeared for the Respondent No. 2

The Court made the following: ORDER

# CRIMINAL PETITION No.10617 OF 2022

# ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners-Accused Nos.1 to 4 seeking to quash the proceedings against them in C.C.No.1023 of 2018 pending on the file of learned Additional Judicial First Class Magistrate, Gajwel, registered for the offences under Sections 447, 427, 379 read with 34 of Indian Penal Code (for short "IPC") Act.

- Heard learned counsel for the petitioners and learned
  Additional Public Prosecutor for respondent No.1-State. Perused the material on record.
- 3. A perusal of the record would reveal that the 2<sup>nd</sup> respondentde facto complainant along with his family members were in peaceful possession of the schedule property. On 04.11.2017, the petitioner-accused No.1 and others up to 25 members criminally trespassed into the schedule property, damaged drip water pipe line and paddy crops, stolen bore well motor. In the charge sheet, prima

facie, there are certain allegations leveled against the petitioners herein. They are triable issues. The petitioners have to face trial and prove their innocence. The defence taken by the petitioners cannot be considered in an application filed under Section 482 Cr.P.C. Therefore, this Court is not inclined to quash the proceedings in C.C.No.1023 of 2018 pending on the file of learned Additional Judicial First Class Magistrate, Gajwel, against the petitioners herein.

4. Thus, having regard to the facts and circumstances of the case, the attendance of the petitioners herein – Accused Nos.2 to 4 is dispensed with in C.C.No.1023 of 2018 pending on the file of learned Additional Judicial First Class Magistrate, Gajwel, when represented by their counsel on record. The attendance of the petitioners-Accused Nos.2 to 4 is dispensed with subject to filing an affidavit by the petitioners stating that in their absence the proceedings conducted by their counsel will not be disputed by them in any manner and also they shall not dispute their identity. However, the petitioners shall appear before the learned Magistrate as and when their presence is required. In the event of the

petitioners failure to appear when the Court directs, this order dispensing his attendance would stand cancelled.

Accordingly, the Criminal Petition is disposed of.

Miscellaneous petitions pending, if any, shall stand closed.
