THE HONOURABLE SRI JUSTICE K.SARATH WRIT PETITION No. 43174 of 2022

ORDER:

Heard Sri Mohd.Islamuddin Ansari, learned counsel for the petitioner, Sri R.Vinod Reddy, Learned Standing Counsel for the respondent Nos.1 to 3 and Sri B Jaganmadhava Rao, Learned Standing Counsel for the respondent No.4. With their consent, the Writ Petition is disposed of at the stage of admission itself.

2. The learned counsel for the petitioner has stated that, the official respondents, without issuing any notice to the petitioner, have disconnected the power supply to the subject Small Cell Infrastructure erected on H.No.3-37, Kothur Village and Mandal, Ranga Reddy District pursuant to the requisition made by 4th respondent-Municipality.

- 3. The learned Standing Counsel appearing on behalf of respondent Nos.1 to 3 has fairly stated that the official respondents have not issued any notice to the petitioner before the power supply was disconnected and only on the request made by the 4th respondent-Municipality the same has been removed.
- A Division Bench of this Court in Writ Appeal No.269
 of 2018, vice order dated 22.02.2018, has held as under:
 - " Disconnection of electricity supply by respondents 2 to 5, on the mere asking of the 6th respondent without even putting the petitioner on notice and without giving him an opportunity of being heard it, in our view, an arbitrary exercise of power."
- 5. In view of the above, the official respondents are directed to restore the power supply to the petitioner, within a period of one week from the date of receipt of a copy of this order. However, this order does not preclude the respondents from putting the petitioner on notice and

calling for an explanation and taking action strictly in accordance with law before passing any orders or taking any action.

 Accordingly, the Writ Petition is disposed of. The miscellaneous petitions pending, if any, shall stand closed.
 There shall be no order as to costs.
