**HON'BLE MR. JUSTICE MAHENDAR KUMAR GOYAL**

**Order**

This writ petition has been filed by the petitioner seeking a direction for the respondents to consider option 'C' as the correct answer to the question no.108 of the multiple choice question booklet in the Rajasthan Constable Recruitment, 2021.

The facts in brief are that the petitioner applied for appointment on the post of constable (GD) in pursuance of advertisement dated 04.12.2019 issued by the respondents. The petitioner appeared in the written examination comprising of 150 multiple choice questions. Question no.108 pertained to the year in which the Pre-natal Diagnostic Techniques (Regulation and

Prevention of Misuse) Act, 1994 (for brevity, 'the Act of 1994') was made applicable. As per the model answer key published by the respondents, correct option shown was (A) i.e. year 1994.

Learned counsel for the petitioner contended that as per the Gazette notification dated 21.12.1995, 01.01.1996 was appended the date on which the Act of 1994 was to apply. She submits that the petitioner has given correct answer by opting 'C'-1996 and hence, the respondents may be directed to award him marks treating his option 'C' to be correct answer to question no.108.

Heard learned counsel and perused the record.

The respondents have already, vide their Circular dated 10.12.2021, held, on the basis of Expert Committee opinion, option 'C', i.e., the year 1996, to be correct answer to the question no.108. This Circular further reveals that objections, if any, have been invited from the candidates against the option 'C'. Since, the grievance raised by the petitioner qua question no.108 has already been taken care of by the respondents on the basis of opinion of the Expert Committee, nothing survives for consideration of this Court in the instant writ petition.

The writ petition is disposed of accordingly.
