These bail applications under Section 439 Cr.P.C. have been filed by the petitioners in connection with FIR No.91/2022 registered at Police Station Kaman District Bharatpur wherein they are charged for offence punishable under Section 395 of IPC.

Learned counsel for the petitioners submits that the indulgence of bail has already been extended to the co-accused persons namely; Harish, Shailesh Namdev, Sakeel & Imran by the

Co-ordinate Benches of this Court and the case of the present petitioner is at par with them. Counsel submits that the petitioner is in custody and trial will take its own time to conclude, so indulgence of bail may also be extended to the present petitioner.

Per contra, learned Public Prosecutor opposed the bail applications.

Considering the arguments put forward by learned counsel for the petitioners and looking to the fact that the co-accused persons namely; Harish, Shailesh Namdev, Sakeel & Imran have already been extended benefit of bail by the Co-ordinate Benches of this Court, without commenting on merits and demerits of the case, I deem it just and appropriate to grant indulgence of bail to the petitioners under Section 439 Cr.P.C.

Accordingly, the bail applications under Section 439 Cr.P.C. are allowed and it is ordered that accused-petitioners **Sohal Son Of Raseed & Shahrukh S/o Sauharab** arrested in connection with aforementioned FIR, may be released on bail; provided they furnish a personal bond of Rs.50,000/- with two surety bonds of Rs.25,000/- each to the satisfaction of learned trial Court with the stipulation to appear before that Court on all dates of hearing and as and when called upon to do so.
