1. Various defects were pointed out by the Registry in these writ petitions.
2. The petitions were filed in December, 2021, whereafter on 27.05.2022 this Court had given four weeks' time to the petitioner to remove the defects, however, the same remained unattended.
3. Thereafter, vide order dated 30.06.2022 further time was granted to remove the defects, still the defects have not been removed.

4. It is to be noted that on both occasions (27.05.2022 and 30.06.2022) no-one appeared on behalf of the petitioner.
