Heard Mr. Kh. Tarunkumar, learned senior counsel assisted by Ms. Th. Rebati, learned counsel appearing for the petitioner and Mr. Niranjana Sanasam, learned Government Advocate appearing for the respondents.

In view of the limited prayer made by the learned senior counsel appearing for the petitioner and as agreed to by both the learned counsel appearing for the parties, the present writ petition is disposed of at the motion stage itself.

The present writ petition had been filed assailing the order dated 20.04.2023 issued by the Commandant Home Guards (VA), Manipur effecting transfer and posting of the present petitioner from Bn. I (HQ) to Bn. IV, Tbl.

It has been submitted by the learned senior counsel that against the impugned transfer order, the petitioner submitted a representation dated 24.04.2023 to the Commandant, Home Guards (VA), Manipur Lamphelpat, requesting for review or recalling the aforesaid transfer order on the grounds mentioned in the said representation. The learned senior counsel further submitted that the present writ petition can be disposed of by directing the

Commandant, Home Guards (VA), Manipur to consider the said representation and on its own merit and in terms of the relevant Rules and to dispose of the same by issuing a speaking order and that till the consideration and disposal of the said representation, the impugned transfer order may be suspended.

Mr. Niranjana Sanasam, learned Government Advocate appearing for the respondents fairly submitted that he has no objection in disposing of the present writ petition as prayed for by the learned senior counsel appearing for the petitioner.

In view of the submissions made above, the present writ petition is hereby disposed of by directing the respondent/Commandant, Home Guards (VA), Manipur to consider the aforesaid representation dated 24.04.2023 submitted by the petitioner on its own merit and strictly in terms of the applicable Rules and to dispose of the same by issuing a speaking order within a period of 15 days from the date of receipt of a certified copy of this order. The petitioner is also directed to furnish a certified copy of this order to the Commandant, Home Guards (VA), Manipur within a period of one week from today.

It is made clear that till the consideration and disposal of the said representation, the petitioner should be allowed to continue at his present place of posting.

With the aforesaid directions, the present writ petition is disposed of.
