Heard Mr. Ajoy Pebam, learned counsel appearing for the applicant, Mr. N. Ibotombi, learned senior counsel assisted by Ms. Babina, learned counsel appearing for the respondent No. 1 and Mr. N. Zequeson, learned counsel assisting Mr. N. Kumarjit, learned senior counsel appearing for the respondent No. 2.

The present application has been filed with a prayer for directing the official/Court witness No. 1 to produce the originals of the following documents before the appointed Advocate Commissioner at the time of his examination:-

Mr. Ajoy Pebam, learned counsel appearing for the applicant submitted that the production of the said original document is only for the purpose of reference by the said official/Court witness No. 1 at the time of his examination and not for the purpose of exhibiting those documents as a piece of evidence in connection with the Election Petition.

Mr. N. Ibotombi, learned senior counsel and Mr. N. Zequeson, learned counsel appearing for the respondents fairly submitted that they have no objection in allowing the present application. Accordingly, the present application is allowed.

Registry is directed to issue a notice to the said official/Court witness No. 1, viz. Oinam Boinao, SDC, Moirang requesting him to produce the aforementioned original documents before the appointed Advocate Commissioner at the time of his examination.

It is made clear that the said original document is only for the purpose of reference by the said witness at the time of examination and not for exhibiting as a piece of evidence.

With the aforesaid directions, the application is disposed of.
