ORDER

The instant Interlocutory Application has been filed by the applicants

seeking impleadment as respondents in the accompanying writ petition.

2. Heard Mr. N.N. Jha, learned counsel for the applicants. Also heard Mr. A. N. Sarmah, learned counsel appearing for the respondent.

3. It is the case of the applicants herein that they are the sons of Late Thir Narayan Singh, which was the brother of Late Ikbāl Kaur and it is on their complaint that the "Next of Kin" Certificate dated 02.08.2014 issued in favour of the writ petitioner/opposite party herein was cancelled vide order dated 08.11.2021.

4. Taking into account the above, this Court is of the opinion that the applicants herein are necessary parties to the accompanying writ petition and without their presence the writ petition cannot be effectually adjudicated upon.

5. Accordingly, this Court therefore impleads the applicants herein as respondent Nos. 3 and 4 to the accompanying writ petition.

6. Learned counsel appearing for the petitioner is directed to file Memo. of parties before the Registry of this Court by 04.01.2024 showing the names of the applicants as the respondent Nos. 3 and 4 in the accompanying writ petition. On the basis of the Memo. of parties so filed, the Registry shall make necessary corrections in the Cause Title of the writ petition and upload the same in the CIS.

7. The Interlocutory Application stands disposed of in terms of the above.
