2. In the aforementioned facts of the case, considering that the order

is a direction to respondent No.3 therein to consider and decide

representation and the memo/letter dated 01.03.2019 would show

that representation of the petitioners was considered and disposed

of directing them to approach the proper authority under the law.

3. In the aforementioned facts of the case, I do not find any good

ground go continue with the contempt proceeding any more.

4. Accordingly, contempt proceeding initiated against respondents is

hereby dropped. Notice issued to respondents stands discharged.
