# Hon'ble Shri Justice Rakesh Mohan Pandey ORDER

# 29.05.2023

- 1. In this batch of petitions, the petitioners have been promoted to the post of Head Master, Primary School from the post of Assistant Teachers (T-Cadre) vide order dated 14.10.2022 and they have been posted vide order dated 3.5.2023.
- 2. Learned counsel for the petitioners would submit that the authority while passing order of posting of the petitioners, has not complied with the circular dated 7.2.2022 and therefore, the petitioners may be permitted to make representation before respondent No.2 to consider and decide their grievances.
- 3. In turn, learned counsel for the State would submit that the representations have already been made by the petitioners before the District Education Officer, Korba and the representations have been sent to the Director, Public Instructions for suitable direction, which are still pending for consideration before the authority. He would further submit that if the

petitioners would make fresh representations before the Director, Public Instructions, same would be considered strictly in accordance with law.

- 4. Considering the fact that some of the petitioners have already joined at the place of posting and some of the petitioners have not given their consent even though they have been posted at different primary schools as Head Masters and further, taking into consideration the fact that the authorities have not considered existing circulars with regard to posting of Head Masters, while issuing posting order dated 3.5.2023, it would be appropriate to issue a direction to the Director, Public Instructions to consider the representations. Therefore, the petitioners are granted liberty to make fresh representations before the Director, Public Instructions and in turn, the said authority is directed to consider and decide the representations, so received, strictly as per existing circulars, within a period of 90 days from today.
- 5. With the aforesaid observation, these petitions are disposed of.
- 6. Interim applications filed in these writ petitions also stand disposed of.
