Order on Board

(31-3-2023)

1. Since an identical issue and facts of law are involved in the bunch of these cases, they are heard analogously and are being disposed of by this common order.
2. In the bunch of these writ petitions, the petitioners are working as Assistant Teachers who have been promoted to the post of Head Master Primary School vide order dated 28-9-2022 and in pursuance of the said order they have joined duties at their respective place of posting but the same order has been cancelled by the District Education Officer, Kondagaon vide order dated 3-10-2022 (Annexure P/1). Thereafter the order was modified and vide order dated 14-10-2022 it has been rectified that the promotion shall remain as it is and it has been done as per decision taken in the meeting of DPC held on 6-10-2022, but the posting order has been cancelled. Therefore, posting of the petitioners has already been protected by the District Education Officer by preserving the promotion order, any posting order has been cancelled.
3. Learned counsel for the petitioners would submit that Co-ordinate Bench of this court has also examined the same issue in WPS No. 1125 of 2023 and other connected matters wherein it has been observed in paras 12 to 15 which read as under.

“12. Director, Public Instruction, Raipur has issued guidelines for posting of Head Master of Primary School and Middle School after their promotion. Relevant portion of the same are as under :-

 4. यथा संभव पदांकन अगर पद रिक्त हो तो उसी संस्था में किया जाये।
 5. पदस्थापना रिक्त पद पर ही की जावे।
 6. पदस्थापना उपरांत अन्यत्र संलग्निकरण न किया जावे।
 7. सम्पूर्ण प्रक्रिया में पूर्ण पारदर्शिता रखी जावे।
- पदांकन में किसी भी प्रकार की अनियमितता की शिकायत प्राप्त होती है तो संबंधित जिला शिक्षा अधिकारी/संयुक्त संचालक जिम्मेदार माने जायेंगे।”

13. The order of promotion is issued on 14.10.2022, which is subsequent to the guidelines issued by Director, Public Instruction. According to the facts and circumstances of the case and the submission of learned counsel for respondents that at the time of issuance of order of promotion, guideline issued by Director, Public Instruction dated 07.02.2022 could not be properly implemented. As per Schedule-I under Chhattisgarh School Education Services (Educational and Administrative Cadre) Recruitment and Promotion Rules, 2019, District Education Officer is the appointing authority for Head Master Primary School. As per Schedule-IV, members of departmental promotional committee are District Education Officer (Chairman), Assistant Director/Equivalent (Member Secretary), Principal DIET, Block Education Officer.

14. In the aforementioned facts of the case, the constitution of Committee by District Education Officer for the purpose of posting of promoted Head Masters will not in any way cause prejudice to petitioners because it is in the interest of larger segment of promoted Head masters. This Court also takes judicial notice of the fact that many promoted Head Masters have approached this

Court by way of filing separate writ petitions mentioning that while promoting them on the post of Head Master Primary School place of posting is not made in accordance with guidelines dated 07.02.2022 issued by Director, Public Instructions, and therefore, also if five members Committee considers the place of posting of promoted Head Master in accordance with the guidelines issued by Director, Public Instruction already in force will not cause any prejudice to petitioners. The submission of learned counsel for petitioners that petitioners are working since the date of their joining at the promoted place is only under interim order passed by this Court.

15. For the foregoing, the order canceling promotion of petitioners by Collector and consequent order passed by District Education Officer dated 19.10.2022 and 20.10.2022 have already been clarified by order dated 03.11.2022 stating that those orders are not the order cancelling the promotion and further the order of Collector constituting the Committee has been canceled by Collector vide order dated 01.02.2023. The Committee constituted is by District Education Officer who is an appointing authority and Chairman of Promotion Committee of Head Master Primary School to post the promoted Head Master”

4. Considering the fact that the petitioners’ promotion has already been protected, therefore, posting order has to be re-examined by the State according to the policy of posting framed by the State Government vide order dated 7-2-2022. As such, liberty is granted to the State to examine the place of posting of the petitioners before starting of new academic session which has to be begun from 16-6-2023 so that the interest of the petitioners as well as the teachers who have to be discharged their duties from the next coming education sessions, will not be adversely affected. It is made clear that if any grievance still exists regarding their posting order, petitioners shall be at liberty to agitate their grievances.

5. With the aforesaid observation and direction, the bunch of these writ petitions stand disposed of.
6. Pending interlocutory applications, if any, also stand disposed of.
