The petitioner has filed the present petition under Article 227 of Constitution of India being aggrieved by order dated 19.04.2012 / 28.05.2012 (Annexure P/7) passed by the Presiding Officer, Labour Court, Mandsaur

(M.P.) in Case No.15/2009 I.D. Act (Reference) whereby while allowing reinstatement of the petitioner - workman in service, Presiding Officer has denied back wages to him.

- 2. The parties have entered into compromise by way of payment of an amount of Rs.10,00,000/- (rupees ten lakhs) as full and final settlement, in view of all the relief granted by learned Labour Court. The amount has been paid to the workman (Bajrang Singh S/o Pepsingh).
- 3. Petitioner (who is present in person) through his counsel has accepted the aforesaid amount of Rs.10,00,000/- (rupees ten lakhs) based on the compromise.
- 4. Affidavit / statement dated 31.10.2023 filed in Writ Petition No.5942 of 2012 is taken on record.
- 5. In view of above statement, Writ Petition No.5639 of 2012 is disposed off finally, as full and final settlement between the parties.

Pending interlocutory application, if any, stands disposed off.
