This application coming on for orders this day, the court passed the following:

ORDER

They are heard. Perused the case-diary.

This is the applicant's first application under Section 438 of Criminal Procedure Code, 1973 for grant of anticipatory bail, as he is apprehending his arrest in connection with Crime No.39/2023 registered at Police Station Badawada, Ratlam (MP) for offence punishable under Sections 306, 420, 406, 120-b of IPC.

The allegation against applicant is of abatement to suicide.

Learned counsel for the applicant submits that co-accused Firoz has

already been granted bail by this Court in M.Cr.C No.15264/2022 vide order

dated 28.04.2023 and the present case is also identical to Firoz.

It is also stated that the complainant has no objection in granting bail to

the applicant.

Learned counsel for the objector submits that he has no objection in

granting bail to the applicant.

Having considered rival submissions, perusal of the case-diary, this

Court is inclined to allow the application.

Accordingly, this application is **allowed**. It is directed that in the event

of arrest, applicant shall be released on bail, upon his executing a personal bond

in the sum of Rs.25,000/- (rupees twenty five thousand only) and furnishing one

solvent surety in the like amount to the satisfaction of the Arresting Officer

(Investigating Officer).

The applicant shall make himself available for interrogation by a Police

Officer, as and when required. He shall further abide by the other conditions

enumerated in Sub Section (2) of Section 438 of the Code of Criminal

Procedure, 1973.
