ORDER

1. This criminal revision has been filed by the petitioner under Section

19(4) of the Family Courts Act, 1984 being aggrieved by the judgment dated

20.05.2022, passed in MJC No.563/2020, by the learned Second Additional

Principal Judge, Family Court, Indore, whereby the learned Family Court has

allowed the application filed under Section 125 of Cr.P.C by awarding interim

maintenance of Rs.2,500/- per month to respondent No.1 and Rs.2,500/-,

Rs.2,500/- to respondent Nos.2 and 3 from the date of application i.e.

09.10.2020.

2. During the course of arguments, counsel for both the parties agreed

that the order of interim maintenance should be initiated from the date of

receiving notice i.e. 09.05.2021 and learned Trial Court may be directed to

conclude the trial within a period of six months.

3. In view of arguments advanced by the counsel for both parties, on

considering circumstances of the case, it is directed that the petitioner is liable

to pay interim maintenance from 09.05.2021 instead of 09.10.2020 and learned

Trial Court is directed to conclude the trial preferably within a period of six

months.

5. Accordingly, the revision stands disposed off.
