following:*

**ORDER**

1] The petitioner has filed the petition under Article 226 of the Constitution of India, seeking the following reliefs:-

"i) This Hon'ble Court may kindly be pleased to direct the respondents to call for the entire record.

(ii) This Hon'ble Court may be pleased to issue a writ of Mandamus or any other suitable writ to direct the respondents to send the name of the petitioner also for consideration in the review DPC in compliance of Order/letter Annexure P/5, and not to consider the case of any one for promotion to the post of Deputy Collector.

(iii) This Hon'ble Court may kindly be pleased to direct the respondents to consider the representation of the petitioner for promotion to the post of Deputy Collector, from amongst Tahsildar within a stipulated period of time.

(iv) This Hon'ble Court may kindly be pleased to direct the respondents to open the sealed cover envelop with regard to the petitioner's grant him all consequential benefits along-with the arrears and interest.

(v) Any other appropriate writ/order/direction, which this Hon'ble Court may deem fit and proper also kindly, be issued in the interest of Justice.

(vi) Cost of the petition may be awarded."

2] Counsel for the petitioner has submitted that in respect of the petitioner grievance, she has also preferred a representations dated 24.11.2011 and 01.5.2023 vide Annexures P/9 but, the same have not been decided by the respondent(s) till date.

3] Counsel for the respondent/State has submitted that if the petitioners file a fresh representation then the same will be considered and decided in accordance with law within a time bound period.

4] On due consideration of submissions and perusal of the record, this Court finds it expedient to dispose of this petition with a direction to the petitioner to file a fresh representation along with all relevant documents within two weeks time before the respondent No.2, who shall decide the same by passing a reasoned order after giving an opportunity of hearing to the concerned parties (if any), in accordance with law, within a further period of three months from the date of receipt of certified copy of this order.

6] With the aforesaid, the writ petition stands **disposed of**.
