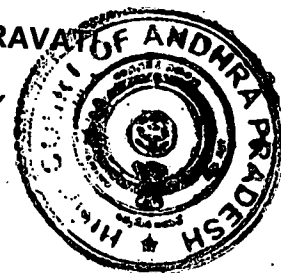

ORDER:



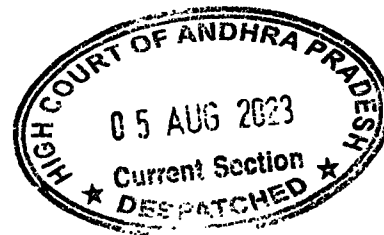
