Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ petition or order more particularly one in the nature of writ of mandamus declaring the action of the 3rd respondent in trying to illegally encroach upon the petitioners land admeasuring Ac 5.00 cents in Sy.No. 60/1, consists cashew and mango trees situated at Karagapadu Village and Panchayat, Gopalapuram Mandal, West Godavari District, without notice, even knowledge about the decree and judgment dt. 03.05.2006 made in O.S.No.629 of 1998 on the file of the I Additional Junior Civil Judge, Kovvuru, declaring the petitioners as the absolute owners and possessors of their respective land, as well the same was ended in finality as the respondents failed to file any appeal against the decree and judgment dt. 03.05.2006 made in OS No.629 of 1998 on the file of the I Additional Junior Civil Judge, Kovvuru, as illegal, arbitrary, unconstitutional, colourable exercise of powers, violative of Articles 14, 19 (1) (g), 21 and Article 300-A of Constitution of India apart from violative of well settled principles of natural justice, consequently direct the 2nd respondent to consider the representation of the petitioners dt.18.05.2015 to issue appropriate directions to the respondents 3 and 5 not to encroach the petitioners land and without following due process of law.


