CRIMINAL PETITION No.3637 OF 2023

ORDER:-

Heard Sri S. Siva Rama Krishna Prasad, Learned Counsel for the petitioner/Accused No.1 and Learned Public Prosecutor for the Respondent-State.

- 2. This Criminal Petition, under Section 438 of Cr.P.C., has been filed by the Petitioner/Accused No.1, seeking anticipatory bail, in Crime No.238 of 2023 of Ongole Taluka Police Station, Prakasam District.
- 3. A case has been registered against the Petitioner/Accused No.1 and others for the offences punishable under Sections 409, 420, 406, 471, 120 (B) r/w 34 I.P.C.
- 4. Case of the prosecution, as stated in the First Information Report, is as under:

"Occurred prior to 11.04.2023 Manappuram Finance Limited, Kurnool road, Ongole and reported in the PS on 16.04.2023 at 17.30 hours by the complainant Mrs. Abhijith Pradhan, Area Head, Manappuram finance limited, age 25 years, Valapad, Thrissur, Kerala State cell no 9390375902 reported that the accused 1) Swarna Vamsi Branch Head, S/o Srinivasarao, age 28 years, Yedugundlapadu village, Ongole mandal 2) Smt Bhuma Kusuma Lakshmi Asst Branch Head, D/o VSK Koteswarao, age 23 years, Ramalayam street, Podili and 3) Golimi Subbulu Custodian D/o Chandram, age 38 years, Kabadi palem, Ongole who were entrusted by the Manappuram authorities cheated the gold ornaments pledged by the customers about 13 items and partly one item, commits criminal breach of trust and forged fake documents and promulgated the rules of Manappuram finance limited with Criminal conspiracy and caused loss to the company for Rs.50,72,695/- and cheated the company."

- 5. Learned Public Prosecutor further submits that earlier the Petitioner/Accused No.1 filed Crl.M.P.No.262 of 2023 on the file of the II Additional District Judge-cum-Special Court for Trial of Offences Against Women, Prakasam District at Ongole, seeking anticipatory bail and the same was dismissed on 09.05.2023.
- 6. Learned Counsel submits that the petitioner is innocent and he is falsely implicated in this Crime.
- 7. Having regard to the facts and circumstances of the case and also taking into consideration the nature of offences alleged against the petitioner-Accused No.1, this

Court is not inclined to grant anticipatory bail to the Petitioner/Accused No.1.

8. Accordingly, the Criminal Petition is dismissed.
