Therefore, the Writ Petition is allowed setting aside the impugned order of preventive detention, dated 04.04.2023 that was passed against the detenu by name Bhukya Sai Babu and the consequential G.O.Rt.No.1102, GAD (SC.I), Department, dated 05.05.2023 that was passed confirming the said order. The detenu by name Bhukya Sai Babu shall be forthwith released and set at liberty, if not required in any other case. There shall be no order as to costs.


