Petition under Sections 437 & 439 of Cr.P.C is filed praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to release the petitioner/Accused No.5, on bail in connection with Crime No.172 of 2023, On the file of Annavaram Police Station, Kakinada District.

This Petition coming on for hearing upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri Kadiyam Neelakanteswara Rao ,Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent.

The Court made the following:

# CRIMINAL PETITION No. 7248 of 2023

## ORDER:

Accused No.5 in Cr.No.172 of 2023 of Annavaram Police Station of Kakinada District, filed the present criminal petition under Sections 437 and 439 of Cr.P.C., seeking to enlarge him on bail. The above crime was registered against the petitioner and others, for the offence punishable under Section 8(c) read with Section 20(b)(ii)(C) of the Narcotic Drugs and Psychotropic Substances Act, 1985.

- 2. Brief facts of the prosecution case are that, on credible information, on 17.07.2023 at about 01.45 p.m., the Sub Inspector of Police, Annavaram PS along with his staff and mediators, apprehended Accused Nos.1 to A.5 at Jam Oil Garden, NH-16 Tuni to Rajamahendravram highway, who were found in possession of 22 Kgs of ganja. After conducting panchanama, after seizing the contraband, the police arrested all the five accused and remanded them to judicial custody subsequently.
- 3. The learned counsel for the petitioner contends that the petitioner was arrested on 17.07.2023 and ever since he is in judicial custody. He further contends that the contraband seized from all the five accused is only 22 kgs, which is a little bit higher than the commercial custody and as such, he requests this Court to enlarge the petitioner on bail.

- 4. On the other hand, the learned Assistant Public Prosecutor opposed the bail application, stating that the contraband seized from the petitioner and others is a commercial quantity.
- 5. This Court perused the entire material on record. As the contraband seized in the present case from all the five accused is 22 Kgs., which is a commercial quantity. In view of the provisions of Section 37 of the NDPS Act, this Court is not inclined to enlarge the petitioner on bail, at this stage.
- Accordingly, the Criminal Petition is dismissed.
