Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Order, Direction one particularly one in the nature of Writ Petition of Mandamus declare the Proceedings of the 4th respondent proc. NIL dt.16-08-2022, as illegal, arbitrary and contrary to the provisions of A.P. Rights In Lands and Pattadar Passbook Act and violation principles of natural justice and consequently direct the 4th respondent to mutate the Petitioner's name and issuance of Pattadar Passbook in respect of the land covered in R.S.No.121/2 an extent of Ac.4.00 Cents situated at Pangidigudem Village, Jangareddygudem Mandal, Eluru District.

The Court made the following: ORDER

THE HON'BLE SRI JUSTICE RAVI CHEEMALAPATI WRIT PETITION NO.29250 OF 2023

ORDER:

The short grievance of the petitioner is issuance of proceedings dated 16.08.2022 by the 4th respondent contrary to the provisions of A.P. Rights in Lands and Pattada Passbook Act and in violation of principles of natural justice.

- Heard, Sri P.R.K.Amarendra Kumar, learned counsel for the petitioner, Sri E.Kumar, learned Assistant Government Pleader for Revenue.
- 3. Learned counsel for the petitioner in elaboration to what has been stated in the affidavit contended that, the petitioner is the owner and possessor of the agricultural land to an extent of Ac.4.00 cents in R.S.No.121/2 situated at Pandigudem Village, Jangareddygudem Mandal. The petitioner filed an application dated 27.11.2021 for mutation of her name in the revenue records and for issuance of pattadar passbook in her favour. On the said application, the 4th respondent issued proceedings dated 16.08.2022, stating that, the petitioner is not in possession and enjoyment of the subject land.

He further submitted that, the petitioner's vendors name is reflected in the form 1-B Register and the petitioner purchased the subject land from his vendor under registered sale deed. As per ROR Act, the authorities have no other option except to mutate the name of the petitioner substituting his vendor's name. Hence, the order impugned is unsustainable and prayed to set aside the order.

- 4. On the other hand, learned Assistant Government Pleader for Revenue submitted that, if the petitioner files a fresh application, the authority concerned would consider the same and prayed to dispose of the Writ Petition in that regard.
- Perused the record.
- 6. Taking the submissions of both the learned counsel into consideration, the order impugned is unsustainable both on facts and law and the said order has been passed in clear violation of principles of natural justice and contrary to the Section 5 of the AP ROR Act. As such, this Court is inclined to dispose of the Writ Petition by passing the following order:

"The order impugned dated 16.08.2022 is hereby set aside. The petitioner is at liberty to file a fresh application and raise all the grounds that are raised and urged before this Court. On such application, the authority concerned is directed to consider and dispose of the Writ Petition in accordance with law as expeditiously as possible".

However, the respondent authorities are not precluded to take action in accordance with law if so desired.

Accordingly, the Writ Petition is disposed of.

There shall be no order as to costs.

Miscellaneous Applications, pending if any, shall stand closed.
