Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of mandamus declaring the action of the respondents in trying to dispossess the petitioner from the land being an extent of Ac. 3-05 cents in Sy.No. 1412/3 situated at Dumpalagattu Village, Khazipet Mandal, YSR Cuddapah District as illegal, arbitrary and violation of principles of natural justice and violative article 14, 21 and 300-A of the Constitution of India and consequently direct the respondents not to interfere in the above said subject land.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to dispossess the petitioner from the land being an extent of Ac. 3-05 cents in Sy.No. 1412/3 situated at Dumpalagattu Village, Khazipet Mandal, YSR Cuddapah District pending disposal of the main writ petition.

**Writ Petition No.33363 of 2023**

**Order:**

The short grievance of the petitioner is that the respondents are interfering with his possession over the subject land admeasuring Ac.3-05 cents, situated in Survey No.1412/3 of Dumpalagattu village, Khazipet Mandal, YSR Kadapa district, without following due process of law.

2. On the other hand, learned Assistant Government Pleader for Revenue, on written instructions dated 20.12.2023 submitted that, the respondents are not interfering with the possession of the petitioner over the subject land. The said written instructions were placed on record and has drawn the attention of this Court to the same.

3. In response to the same, Sri V. Jagadish, learned counsel, representing Sri Narsimhulu Parise, learned counsel for the petitioner, requested to record the written instructions and prayed to close the Writ Petition.

4. A perusal of the written instructions which are placed on record shows that, the petitioner is in possession and enjoyment of the subject land and the respondents never interfered with his

possession. In view of the same, there remains nothing for adjudication and the Writ Petition is liable to be closed.

5. Accordingly, the Writ Petition is closed. There shall be no order as to costs.

As a sequel thereto, the miscellaneous applications, if any, pending in this Writ Petition shall stand closed.
