ORDER:

The present Writ Petition came to be filed under Article 226 of the Constitution of India seeking the following relief:-

"to issue an order, direction or writ, more particularly one in the nature of writ of Mandamus declaring the inaction of the respondent in appointing the Presiding Officer of the Industrial Tribunal cum Labour Court, Visakhapatnam as illegal, arbitrary and violative of the provisions of the Industrial Disputes Act, 1947 and consequently direct the respondent to appoint the Presiding Officer of the Industrial Tribunal Cum Labour Court, Visakhapatnam forthwith and pass such other order or orders"

- 2. At the time of hearing, the learned Government Pleader for Labour has produced a copy of G.O.RT.No.656, dated 26.09.2016, by which, one Smt.P.Annapurna has been appointed as Chariman-cum-Presiding Officer, Industrial Tribunal-cum-Labour Court, Visakhapatnam.
- 3. The learned counsel for the petitioner has seriously objected stating that that though the Chairperson was appointed in the year 2016 after filing of the writ petition, as on today, the Chair of the Industrial Tribunal-cum-Labour Court is lying vacant since more than one year.

- 4. In view of the same, this Court feels it appropriate to direct the respondents to take appropriate steps for appointment of Chairperson as Presiding Officer for the Industrial Tribunal-cum-Labour Court, Visakhapatnam at an earliest date, preferably within a period of three (3) months from the date of receipt of copy of this order.
- 5. With the above direction, this Writ Petition is closed. There shall be no order as to costs.

Miscellaneous petitions pending, if any, in this Writ Petition shall stand closed.
