#### **COMMON ORDER**

Since the issues involved in all these petitions are similar, they are taken up together, heard and disposed off by this common order.

- 2. These petitions are filed challenging the order passed by the I Additional Senior Civil Judge, Ballari, by which the review petitions filed by the petitioners herein under Order XLI Rule 1 read with Section 151 of CPC came to be dismissed as not maintainable.
- 3. The I Additional Senior Civil Judge, Ballari in the petitions filed under Section 18(1) of the Land Acquisition Act by the respective land owners enhanced the compensation from Rs.5,00,000/- to Rs.10,00,000/-, Rs.6,00,000/- to Rs.11,00,000/- and from Rs.8,00,000/- to Rs.13,00,000/-.
- 4. The petitioners herein filed review petitions under Order XLVII Rule 1 of CPC stating that the award passed by the reference Court is an error apparent on the face of the record since the Land Acquisition Officer had fixed the marked value of



the lands acquired at Rs.1,50,000/- per acre for the lands situated in Kuditini village, Rs.2,31,000/- for the lands situated at Kolagallu village, Rs.1,86,000/- for the lands situated in Veniveerapura village and not at the rate of Rs.5,00,000/-, Rs.6,00,000/- and Rs.8,00,000/-.

3. The issues involved in these petitions were examined by the Co-ordinate Bench of this Court in Writ Petition Nos.102481, 102482, 101505, 101507, 102009 of 2023, wherein it was held that review petitions filed by the petitioners are maintainable and there was an error apparent on the face of the record in determining the market value of the lands acquired. Therefore, these petitions also requires to be disposed off in terms of the order passed by this Court in the Writ Petition Nos.102481, 102482, 101505, 101507, 102009 of 2023. Accordingly, I pass the following:

#### **ORDER**

Writ petitions are allowed.

The order dated 02.02.2023 passed by the I Additional Senior Civil Judge, Ballari in R.P. Nos.22, 24, 30, 32, 31, 21,
