2. In this writ petition, the petitioners have sought for a direction to the respondents to consider their representations dated 27.12.2016 and 15.01.2018 (Annexures - 'L' & 'M').

Having taken note of the factual aspects on record, the grievance of the petitioners is that the petitioners' Association has made a representation to respondent No.2, regarding recovery of higher House Rent Allowance paid to the Bangalore based employees after retirement for the period from 01.06.2000 to 30.09.2007 (Annexure 'L').
4. In this view of the matter, taking into consideration the grievance of the petitioners, respondent No.2 is directed to consider their representations produced at Annexures - 'L' and 'M' within a period of eight weeks from the date of receipt of a copy of this order.
