ORDER

The learned counsel for the appellant is neither present physically nor through Video Conference. No reasons are forthcoming for non-appearance of learned counsel for the appellant, as well for non-compliance of office objections.

2. A perusal of the order sheet would go to show that after giving several and sufficient opportunities, since the appellant has not complied the office objections, a Co-ordinate Bench of this Court in this matter has passed the following order on 26.08.2022:
