THIS WP IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA PRAYING TO a) ISSUE A WRIT IN THE NATURE OF CERTIORARI OR ANY OTHER APPROPRIATE WRIT ORDER QUASHING THE AUCTION NOTIFICATION DATED 30.05.2014 IN NO.KA.GRU.MAM.U.PRA.VYA(GRA.SE)/ HANCHIKE/LOTTERY/KA.SUM.01/2014-15 ISSUED BY RESPONDENT NO.6 AND PUBLISHED IN VIJAYA KARNATAKA, KANNADA DAILY DTD 06.06.2014 VIDE ANNEX-T IN SO FAR AS IT PERTAINS TO ITEM NO.1 IN RESPECT OF LAND SY.NO.120 OF SOGANE VILLAGE, SHIVAMOGGA TALUK AND DISTRICT AND ETC.

THESE PETITIONS, COMING ON FOR ORDERS, THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

This writ petition is filed by the petitioners seeking to quash the notification dated 30.05.2014, issued by respondent No.6 published in Vijaya Karnataka daily News paper dated 06.06.2014, in so far as pertaining to the item No.1 of the land bearing Sy No.120 of Sogane Village, Shivamogga District.

2. The petitioners claimed to be the residents of Sogane Village in possession of different extent of the land



in Sy.No.120 of Sogane village, Nidige Hobli, Shivamogga District. That said land bearing Sy.No.120 of Sogane Village was proposed and acquired for construction of Shivamogga Airport. Petitioners had sought for regularization of their unauthorized cultivation of the subject land. It is submitted that the petitioners were assured that they would be paid certain compensation in addition they will also be allotted a site measuring 40X60 each with all the facilities and civic amenities. Acting upon the representation made to the petitioners on behalf of the Government they had handed over the possession. That the petitioners were paid only part of the compensation.

3. However, the Government had not taken decision in regularizing the land. It appears in furtherance to the assurance made by respondent-State, a communication was addressed to the Commissioner, Karnataka Housing Board, Bengaluru informing that the Deputy Commissioner had identified about 30 acres of land to form 300 sites for the purpose of rehabilitation of the farmers who had lost their land. In furtherance thereof an extent of 34 acres



and 9 guntas of land in Sy.No.120 of Sogane Village had been developed into residential layout by the Karnataka Housing Board.

4. Since the aforesaid assurance and representation did not materialise in actual conveyance of the sites in favour of petitioners and on other hand KHB instead of allotting the sites to the petitioners and alike land losers, had called for application for allotment of sites in the very same layout, which was to be allotted to the petitioners, they approached this Court seeking the reliefs as noted herein above.

5. Due to the pendency of this petition and considering the case of the petitioners herein the Karnataka Housing Board has handed over the developed layout to the District Administration Shivamogga to an extent of 34 acres 9 guntas. The said layout is now referred to as 'Sogane Layout'. A communication in this regard, has been issued by the Karnataka Housing Board dated 20.02.2023 addressed to the Deputy Commissioner, Shivamogga District, Shivamogga.



6. This Court by order dated 20.08.2023 taking note of the submission made by Sri. Jayakumar S Patil, learned senior counsel appearing for petitioners and also learned counsel appearing for respondent - Karnataka Housing Board and learned AGA, had directed the Principal Secretary of Revenue Department to consider the request made by the respondent-KHB for payment of development charges and to ensure that the developed layout is handed over by the Karnataka Housing Board to the Revenue Department. Today it is submitted that even before the order dated 28.08.2023 passed by this Court, the communication dated 20.02.2023 referred to above has been exchanged. However, the same was not made available to this Court for consideration. Respondent-State has filed memo dated 03.03.2023 along with a communication issued by the office of Assistant Commissioner, Shivamogga, Sub-division Shivamogga, addressed to Additional Government Advocate informing about the sanction of development charges and the instructions having been issued for handing over the



layout to the District Administration. Proceedings of the Karnataka Housing Board held in the meeting dated 07.05.2022 is also enclosed.

The said memo read as under:

The Respondents - State humbly submit as follows:-

1. The Petitioners are asserting their cases on the basis of their filing applications seeking regularization of their unauthorized cultivation in Sy.No.120 of Sogaane Village, Nidhige Hobli, Shivamogga District. It is relevant to state that the said land has been utilized for the purpose of construction of Shivamogga Airport and the Karnataka Housing Board is formed layout in the portion of that Survey Number measuring 34 acres 9 guntas. The Government is taken a decision on the basis of the Board Resolution of the Karnataka Housing Board dated 07.05.2022; wherein, it is resolved to allot sites to the 343 bagur hukkm cultivators in the layout formed by the Karnataka Housing Board and the Karnataka Housing Board, vide its Communication dated 20.02.2023, the layout called 'Shivamogga Sogaane Layout' has been handed over to the District Administration to take further steps to allow the sites to the 343 bagur hukkm cultivators. The Assistant Commissioner, Shivamogga Sub-Division, Shivamogga vide his Communication dated 21.02.2023 has informed that the office of the Deputy Commissioner, Shivamogga is taking necessary steps to allot sites to 343 bagur hukkm cultivators.

2. In that view of the matter, the above Writ Petitions may be disposed of, in order to enable the District Administration to take steps



to allot sites to 343 bagur huklum cultivators in the Shivamogga Sogaane Layout formed in Sy.No.120 of Sogaane Village by the Karnataka Housing Board. Copies of the resolution dated 07.05.2022, Communication of the Karnataka Housing Board dated 20.02.2023 and Communication of the Assistant Commissioner, Shivamogga Sub-Division, Shivamogga are herewith produced for kind consideration of this Hon'ble Court.

Wherefore, it is humbly prayed that this Hon'ble Court may be pleased to take this Memo on record and dispose of the above Writ Petitions, in the interest of justice and equity.

7. In view of the aforesaid subsequent development more particularly the proceedings of the Karnataka Housing Board dated 07.05.2022 resolving to hand over the developed area, forming part of Sy.No.120 measuring 3 acre 9 guntas to the District Administration and confirmation of the same by the Karnataka Housing Board in terms of communication dated 20.02.2023 addressed to the Deputy Commissioner, Shivamogga District, Shivamogga and in view of the memo filed as noted herein above, the issue is with regard to validity or otherwise of the acquisition may not survive for consideration. Though the formalities for development and handing over has



been completed, since the direction is sought for directing the respondent to allot the site measuring 60X40 to all the petitioners and alike land losers in the aforesaid layout formed in land measuring 34 acre 9 guntas in Sy.No.120, it would be appropriate that, respondent Nos.3 to 5 shall ensure that the sites as assured are allotted to the petitioners. Needless to state that the respondent Nos.3 to 5 are at liberty to call for allotment of sites.

8. Sri. Jayakumar S Patil, learned senior counsel appearing for petitioners brings to the notice of this Court that the names of the occupants in the subject land bearing Sy.No.120 has been prepared by the respondent-Assistant Commissioner as per Annexure-B to the writ petition, which consist of about 302 names with the particulars of the extent occupied by the said persons. Learned senior Counsel further brings to the notice of this Court, the names of the petitioners which are mentioned to the said Annexure-B and separately produced in Annexure-K. In that view of the matter, it is submitted that aforesaid list was prepared at the time of granting



award, a sum of Rs. 2,00,000/- per acre as compensation to the land losers.

9. In that in view of the matter and in view of the availability of the details of the land losers and including the petitioners, respondent Nos.2 to 5 shall allot the sites as assured. The said exercise shall be completed within a period of 3 months from the date of receipt of certified copy of this Order.

10. Needless to state, since this writ petition is disposed off in view of the memo of disposal filed by the respondent-authorities along with the communication referred to therein, should be there be any issue requiring consideration, that the petitioners are at liberty to approach before this Court.

In view of the above observation this writ petition is disposed off.
