## **ORDER**

The subject matter of this Writ Petition is substantially similar to W.P.No.14769/2023 (GM-FC) between SRI. N.RAJEEV vs. SMT. C.DEEPA, which was disposed off by this Court on 26.07.2023, wherein a period of one year is prescribed for making all efforts for trial & disposal of matrimonial cases involving a prayer for Decree of Dissolution of Marriage.

2. The Division Bench of this Court in W.A.Nos. 932-933/1974 between A.V.VINODA & ANOTHER Vs. STATE OF KARNATAKA BY ITS COMMISSIONER & SECRETARY disposed of on 11.12.1974, has held that the Court should treat the like-cases alike and if relief is granted to a litigant it has to be extended to a similarly circumstanced litigant as well, there being no derogatory circumstances.

In view of the above, learned V Additional Principal Family Judge, Bengaluru, is requested to try & dispose off
