- 4. Having heard the learned counsel appearing for the parties, I am of the view that, the impugned order was passed on 28.11.2006 and challenged before this Court in the present writ petition after an in ordinate delay of 17 years from the order passed by respondent No.2 herein.

Having taken note of the averments made in the writ petition and explanation offered by the petitioner with regard to condoning the delay of 17 years in filing the petition, cannot be considered as sufficient ground to condone the delay of 17 years delay in challenging the impugned order passed by the Land Tribunal, has been not made in terms of the declaration of law made by the Hon'ble Apex Court in the case of **State of**
