#### **JUDGMENT**

- 1. This petition is filed under Section 115 of CPC challenging the order dated 11.8.2023 passed by the Principal City Civil and Sessions Judge, Bengaluru in Misc.No.565/2023 filed under Section 24 of CPC for clubbing O.S.No.3142/2022 with O.S.No.2218/2023, whereby the said petition has been dismissed by the Trial Court.
- 2. Initially, the petitioners/plaintiffs had filed O.S.No.3142/2022 for declaration before the Addl. City Civil and Sessions Judge (CCH-16), Bangalore. Thereafter, plaintiffs filed comprehensive had а suit O.S.No.2218/2023 before the Addl. City Civil and Sessions Judge (CCH-13) for declaration and injunction. The plaintiffs filed Misc.No.565/2023 before the Prl. City Civil and Sessions Judge, Bangalore praying to transfer the suit in O.S.No.3142/2022 to the court where the suit in O.S.No.2218/2023 is pending. The Trial Court by



impugned order has dismissed the said petition. Hence, the present appeal is filed.

- 3. The learned counsel for the petitioners/plaintiffs submitted that since the plaintiffs intend to prosecute the matter in O.S.No.2218/2023, they want to withdraw the suit in O.S.No.3142/2022. To that effect, a memo dated 31.8.2023 is filed by the learned counsel for the petitioners before this Court.
- 4. The said memo dated 31.8.2023 filed by the learned counsel for the petitioners is placed on record.
- 5. Accordingly, I pass the following order:

### <u>ORDER</u>

- a) The petition is disposed of.
- b) The petitioners/plaintiffs are permitted to withdraw O.S.No.3142/2022 pending on the file of Addl. City Civil and Sessions Judge (CCH-16), Bangalore and pursue the suit in O.S.No.2218/2023

on the file of Addl. City Civil and Sessions Judge (CCH-13), Bangalore.

c) An application under Order 39 Rules 1 and 2 of CPC is filed in O.S.No.2218/2023 and the same is pending. Till the said application is disposed of by the Trial Court, the parties are directed to maintain status-quo.

d) The Trial Court without being influenced by the order passed by this Court in MFA No.5292/2022 disposed of on 5.1.2023, shall dispose of the application filed under Order 39 Rules 1 and 2 of CPC, in accordance with law.
