THIS PETITION, COMING ON FOR ORDERS, THIS DAY, THE COURT MADE THE FOLLOWING:

<u>ORDER</u>

Sri.Pawan Kumar, learned counsel takes notice for respondents.

Short grievance of the petitioner is that respondent authorities having issued notice at Annexure-E dated 29.11.2023 under Section 248(2) of BBMP Act, 2020, without even providing an opportunity to the petitioner to file his response have even issued confirmation order under Section 248(3) of the BBMP Act. Petitioner submits that the respondents have not even provided sufficient opportunity to the petitioner.



- 2. Sri.Pawan Kumar, learned counsel undertaking to represent respondents submits that petitioner has alternate and effective remedy by way of filing an appeal provided under the Act before the Chief Commissioner.
- 3. In view of the effective alternate remedy being available to the petitioner, petitioner is relegated to file appeal within a period of 15 days from the date of receipt of certified copy of this order, which shall be adjudicated in accordance with law. Respondent authorities shall not precipitate the matter till the petitioner files the appeal within 15 days as above.

Petition is disposed of accordingly.

Sri.Pawan Kumar, learned counsel is permitted to file vakalath for respondents within two weeks.
