JUDGMENT

Petitioners in these cases are allottees of plots in a housing development project undertaken by the Rubber Board Employees Housing Co-operative Society Ltd., a Society registered under the provisions of the Kerala Co-operative Societies Act, 1969. The petitioners in these cases have raised various grievances regarding the activities of the aforesaid Society.

2. According to the petitioners, the managing committee members of the Society had cornered the most valuable amongst the plots by paying amounts which are substantially less than the amounts paid or demanded from petitioners in these cases. They also raise a dispute regarding their liability to pay development charges/common area charges as demanded by the Society. However they do not dispute the land value fixed by the Society.

3. When these matters came up for consideration before me on 27-01-2023, after hearing the learned counsel appearing for the petitioners, the learned counsel appearing for the Society and the learned Special Government Pleader appearing for the State of Kerala and other official respondents, I had suggested to the learned counsel appearing for the petitioners in these cases that the reliefs sought for in these writ petitions could possibly be raised only in proceedings initiated under Section 69 of the Kerala Co-operative Societies Act, and not in a writ petition filed under Article 226 of the Constitution of India.

4. The learned counsel appearing for the petitioners in these cases sought time to obtain instructions from his clients and it is accordingly that these matters are listed for consideration today.

5. The learned counsel appearing for the Society would submit that 29 persons amongst the allottees who are similarly placed like the petitioners in these cases have already paid the land value and the common area

charges/development charges and accordingly the sale deeds have been executed in their favour. It is submitted that if the petitioners in these cases pay the land value charges and also the common area charges/development charges in the same manner as was paid by the 29 allottees in whose favour the sale deeds have been executed, the plots in question can be conveyed to the petitioners in these cases, making it clear that all disputes raised by them including the dispute regarding their liability to pay common area charges/development charges can be adjudicated in proceedings under Section 69 of the Kerala Co-operative Societies Act.

6. The learned counsel appearing for the petitioners in these cases would submit that if the liberty of the petitioners in these cases, to raise all disputes in proceedings under the Kerala Co-operative Societies Act is left open, these writ petitions can be disposed of directing that if the petitioners in these cases remit the amount payable by the the petitioners towards the land

value/development charges/common area charges, as made applicable in respect of the 29 persons to whom the plots have already been conveyed, the plots in question shall be conveyed to the petitioners. It is submitted that the liability of the petitioners to pay common area charges/development charges as well as any other disputes raised by them regarding the Society can be taken up before the appropriate Authority under the Kerala Co-operative Societies Act, 1969.

7. Having heard the learned counsel as above, these writ petitions will stand disposed of directing that on the petitioners in these cases paying the amounts payable by them towards the land value/common area charges/development charges as made applicable to the 29 allottees, to whom the land has already been conveyed, the plots allotted to the petitioners in these cases shall be conveyed to them by executing registered sale deeds. The cost of registration shall also be met by the petitioners. It will be open to the petitioners in these cases to either

individually or collectively approach the competent authority under the Kerala Co-operative Societies Act, 1969, for resolution of their disputes with the Society. All other contentions raised by the parties in these cases are left open for consideration, in such proceedings. This order will not be treated as an adjudication by this Court on any of the contentions raised by the parties in these cases.

These writ petitions are disposed of as above.
