THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 25.08.2023, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

This writ petition is filed seeking the following reliefs:-

- "i) issue a writ in the nature of mandamus or any other appropriate writ, order or direction commanding the 2, 3 and 4 respondent to collect pension contribution to the EPF pension scheme of the petitioners on the basis of the actual salary drawn by them, in accordance with Proviso to Clause 11(3) of the Employees Provident Fund Scheme, 1995, from the date of joining the pension scheme and also to direct the 4th respondents to furnish joint application expressing the consent and direct the 2nd respondent to pay pension and its arrears on the basis of the actual salary drawn by the petitioners:
- ii) declare that the petitioners are entitled to get pension contribution to the EPF pension scheme of the petitioners on the basis of the actual salary drawn by them, in accordance with Clause 11(3) of the Employees Provident Fund Pension Scheme, 1995, from the date of joining the pension scheme."
- 2. The petitioners are retired employees of the 4th respondent establishment. They are subscribers of Employees' Provident Fund. According to the

petitioners, they are entitled for higher pension under the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 as per the option exercised by them. It is their case that the pension has to be paid without limiting the amount to the maximum pensionable salary prescribed in paragraph 11(3) of the Employees' Pension Scheme, 1995.

3. Smt.Nita N.S., the learned Standing Counsel for the Employees' Provident Fund Organisation submits that the question raised in the writ petition is now settled by the Hon'ble Supreme Court in EPF Organisation and Another v. Sunil Kumar B and Others [2022 SCC online SC 1521] and that the grievance of the petitioners raised in this writ petition will be considered in accordance with the directions therein.

In the light of the said submission, this writ petition is disposed of directing the competent among

the respondents to re-consider the claims put forward by the petitioners in the light of the dictum laid down by the Hon'ble Supreme Court in the decision cited above within a period of three months from the date of receipt of a copy of this judgment.
