THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 31.07.2023, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

Dated this the 31st day of July, 2023

The petitioner is aggrieved by the fact that his trade licence is not being renewed on the ground that the unauthorised constructions have been made by the landlord. For the fault of the landlord, the petitioner cannot be penalised. The petitioner's application for renewal of trade licence is liable to be allowed, contends the petitioner.

2. Standing Counsel entered appearance and resisted the writ petition. The Standing Counsel submitted that apart from the illegality in the construction, the petitioner has not submitted requisite documents for grant of renewal. The petitioner was required to produce identity card, receipts in proof that the entire professional tax dues are paid and a licence from the Pollution Control Board. As the petitioner

has not produced these documents and since the building is unauthorised, the application was not processed.

- 3. I have heard the learned counsel for the petitioner and the learned Standing Counsel representing the respondents.
- 4. It is submitted at the Bar that the legality of the construction made by the landlord is pending consideration before this Court in W.P.(C) No.11864 of 2023. As the matter is pending before this Court, the petitioner being a tenant, it would be unjust to deny renewal of trade licence to the petitioner on that ground.
- 5. The counsel for the petitioner would submit that the petitioner has already submitted the Consent from the Pollution Control Board and the petitioner is willing to pay the arrears of professional tax and produce copy of identity card.

In the circumstances, the writ petition is disposed of directing that if the petitioner produces copy of identity card, receipt in proof of payment of professional tax and the Consent obtained from the Pollution Control Board to the
