JUDGMENT

Petitioner alleges that he is the Secretary of a school by the •MVM Residential Higher Secondary School, name Valayamkulam, Kokkur P.O., Ponnani Taluk, Malappuram District, under the management of a trust named 'Assabah Association Trust'. Petitioner alleges that the school is situated the Valayamkulam Centre of Kozhikode-Thrissur State Highway. Petitioner alleges that, there are several encroachers who have constructed bunk and are indulging in illegal business causing obstacles to the free passage of students, teachers and other persons including the kindergarten children. Pointing out the illegal encroachment and occupation of the roadside margins by the encroachers, a complaint was preferred before the first respondent and other statutory authorities.

2. According to the petitioner, in the absence of any direction, respondent will fail to take any decision on the complaint filed

by him and hence he has approached this Court.

- 3. Having heard the learned counsel for the petitioner, as well as the learned Government Pleader, I am of the view that this writ petition can be disposed of, dispensing with notice to the first respondent, considering the nature of order that I propose to issue.
- 4. Since Ext.P1 is pending consideration before the first respondent, it is necessary that a decision be taken after hearing the petitioner as well as the Executive Engineer of the Public Works Department.
- 5. Therefore, there will be a direction to the first respondent to consider and pass appropriate orders on Ext.P1 complaint filed by the petitioner as expeditiously as possible, at any rate, within a period of 60 days from the date of receipt of a copy of this judgment, after granting an opportunity of hearing to the petitioner as well as the 2nd respondent.

With the above observation, this writ petition is disposed of.
