ORDER

This is a petition filed under Section 482 of the Code of Criminal Procedure to quash Annexure-2 final report and all further proceedings in Crime No.560/2022 of Kodanad Police Station, now pending as C.C.No.498/2022 before the Judicial First Class Magistrate's Court-III, Perumbavoor. The offences alleged against the petitioners are under Sections 341, 294(b) and 427 read with 34 of the Indian Penal Code.

- 2. The learned counsel for the petitioners submits that, as regards the first accused, this Court has quashed the entire proceedings in Crl.M.C.No.887/2023.
- 3. The learned Public Prosecutor submits that the instruction proceeds reveal that the petitioners have no antecedents and this is the only crime registered against them. Annexure-3 is an affidavit filed by the de facto complainant stating that the compromise settlement arrived between the petitioners and the de facto complainant can be accepted and the proceedings against
