ORDER

Heard the learned counsel appearing for the petitioners, the learned Public Prosecutor representing the 1st respondent and the learned counsel Adv. Noel Jacob appearing for the 2nd respondent.

- 2. The present Crl.MC is filed under Section 482 of the Code of Criminal Procedure for quashing Annexure-A1 F.I.R. in Crime No.154/2023 of Hill Palace Police Station, Ernakulam and all further proceedings pursuant to it.
 - 3. It is submitted by the counsel

representing the petitioners and the second respondent that the dispute between the parties have been amicably settled pursuant to a mediation at the instance of High Court Mediation Centre. A copy of the memo of settlement under Section 89 of the Code of Civil Procedure r/w Rules 24 and 25 of the Civil Procedure (Alternative Dispute Resolution), Rules 2008 has been brought on record as Annexure-A4.

4. The learned Public Prosecutor representing the 1st respondent also submitted that she has got instructions from investigating parties officer that the amicably sorted out the dispute between them and that the defacto complainant had given a statement before the 1st respondent that he is not at all interested in proceeding with the prosecution pursuant to Annexure-A1 F.I.R. A copy of the statement submitted by the Inspector of Police, Hill Palace Police Station is placed before me for perusal.

5. Having regard to the facts and circumstances of the case as revealed from the above records, as well as the submissions at bar, I feel that the criminal proceedings pursuant to Annexure-A1 F.I.R. are totally unnecessary. continuation of the above criminal proceedings will not serve any purpose and it will only lead to the abuse of process of court. In the above circumstances, it appears to be necessary in the interest of justice to quash all further proceedings pursuant to Annexure-A1 F.I.R. registered in Crime No.154/2023 of Hill Palace Police Station, Ernakulam City.

In the result, the petition stands allowed.
